Construction of the new pavilion at Park West (north) is complete.

Pensacola Beach Playgrounds and Interactive Splash Pad

Topographic surveys have been completed and construction documents are being produced. Improvements will take place at Harry Gowens Park, Cowley Park and Park West (North).

Pensacola Beach Multi-Use Path Restoration – Phase 1

Survey activities have been completed and design is underway for the multi-use path from Avenida 10 to Parking Lot D. A change in scope was authorized by SRIA staff to extend the path restoration from Avenida 10 westward to the core area. Design estimates for the path extension are in process.
