### **Banner Construction:**

1. Minimum size: 3' x 30' – Maximum size: 5' x 30'
2. Material: Heavy gauge reinforced vinyl with a minimum of 31 six inch wind pockets.
3. Two (2) sixty-five foot (65') 3/8" double braided, non-stretchable nylon rope threaded through the top and bottom hems. Reinforcing grommets are required for each corner of the banner. The rope must be threaded through the hems of the banner at the time the banner is installed.
4. Banners not meeting the banner construction guidelines will not be displayed.
5. A full "to scale" color rendering of the banner must be attached to the banner application, which will be retained by the SRIA.
6. Secondary advertising on the banner is limited to 15%.
7. Applications will be reviewed by the SRIA staff. Applications not meeting the criteria contained in the policy will be denied and the application fee refunded.
8. Banner will be installed & removed by the applicant in a safe & reasonable manner. **Escambia County Public works cannot assist in hanging banners.**

Pensacola Beach businesses will be permitted to use the banner poles for the following:

- 1. One time only for the Grand Opening of a business. Each business will be permitted only one Grand Opening banner.
- 2. For events defined as: special unique activities open to the public offering activities such as food and entertainment that is not a daily, weekly or monthly occurrence.
- 3. Banners may be displayed on the Monday of the week the event is held and removed the following Monday.
- 4. Banner poles are not available for daily, weekly or monthly specials.
- 5. Businesses can only use the banner poles once in each quarter.
- 6. If the banner becomes damaged the applicant must remove it immediately.
- 7. If any damage is done to the banner poles due to installation or use the applicant will be responsible for all costs associated with the repair of the poles.
- 8. The applicant must provide liability insurance in the amount of \$1,000,000 listing the Santa Rosa Island Authority and Escambia County as additional insured each time the banner poles are used.

**Hold Harmless and Indemnification**
