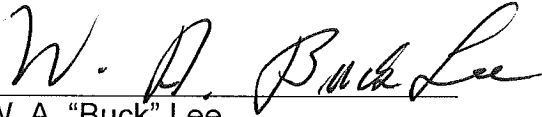
The Committee suggested the following changes to the RFQ that was presented by Mr. Mike Langston.

- Qualifications will be received until 2:30 p.m. central time Wednesday, April 22, 2009 and will be opened at 4:00 p.m. central time
- Page 1 last paragraph change to at least five (5) working days prior to the April 22, 2009 deadline
- Under Scope of Work – the area for planning concepts is located along Pensacola Beach Boulevard and Via de Luna
- Under Required Consultant Team Qualifications #1 change to Proficiency in Coastal Resort Design, Streetscape, Context Sensitive Design and New Urbanism
- Change Required Consultant Team Qualifications to paragraph # 2
- Change Submittal Requirements to paragraph # 3
- Change Consultant Selection Process to paragraph # 4
- Under Consultant Selection Process # 2 change to At the Board's Option, a minimum of two (2) short-listed consultants may be invited to present design qualifications in a public forum at the Santa Rosa Island Authority boardroom.
